Under the terms of this contract, developer appoints distributor as a non-exclusive distributor for the following software developer (software:) [software.] the distributor must sell copies of the software supplied by the developer to customers for the or only in the United States during the term of this contract. the distributor does not have the right to make copies of the software. the distributor does not distribute any copy of the software without the end user software license agreement. the distributor will not export any software outside the United States. The distributor will use its best efforts to promote, market and sell software to retailers, retailers and other retailers. b. orders for copies of the software. any and all orders from the distributor for copies of the software comply with the terms and conditions of thisThese terms and conditions replace any additional or conflicting terms or conditions contained in any purchase order or other communication by the Distributor. Orders must be in writing, delivered in person, by post, night delivery service or fax machine. Each order must be for a minimum of units [Minimum Order]. C. New Versions. In the event that Developer releases a new version of any Software product during the end of this Agreement, the Distributor may return, within [Return Period] after the first shipment of the new version to Distributor, any copy of the old version of that software product held by Distributor in inventory and obtain a copy of the new version of that Software product for each copy of the old version returned by Distributor to Developer. The distributor does not have the right to return copies of the old version that were sold by the Distributor before the release of the new version. The distributor will pay the shipping costs both to and from Developer. Q. Come back. The Distributor may return any unit of the Software that is delivered by defective means or with damaged packaging or documents, provided that such defects or damages are not the fault of the Distributor. The Distributor may return any unopened units of Software during the end of this Agreement provided that the Distributor pays to Developer a supply charge in the amount of [Restock Charge] of the current price of the Developer for that Software, and provided that copies returned byare current versions of the Software at the time of such return. The distributor must request and receive an authorization number of materials before returning any material. [Sale Guarantee] E. Recommended retail price. If Developer reduces the recommended retail price of the Software, the developer grants a fix for Distributor on any unsold software in the Distributor's physical inventory. The amount of the adjustment shall be equal to the amount of the change in the retail price recommended. This change will be provided only in the form of credit against the subsequent purchases of the Software by the Distributor. F. marketing funds. The developer may agree to provide the Distributor with funds for various marketing activities in case by case. Developer recognizes the importance of promoting its products and will help Distributor do so. The reimbursement of marketing expenses requires prior written authorization from the Developer. All terms of marketing agreements are specified in authorizations. Payment requests are submitted with proof of performance and copy of the authorization. Developer specifically states, and Distributor recognizes, that Developer does not offer a CO-OP marketing fund that empowers Distributor to matre dollars for sales-based marketing. A. Prices. For each copy of the Software ordered by the Distributor, the Distributor must pay the Developer the price as follows: [Distributor Price Schedule]. Prices aresubject to change to the only option of the developer on [Notice for Price Change] written notice to Distributor. The distributor must pay the amount within thirty (30) days from the developer's invoice. B. Taxes. The Distributor must pay, or refund The developer as appropriate, for any sale, use, excise, property or other tax imposed on the supply of the Software to the Distributor and the amounts paid by the Developer below. In no event, the Distributor is responsible for the income-based taxes of the developer or the privilege of doing business. 3. Deadline and termination. A. Deadline. The initial term of this Agreement begins the [Start date] and will continue for a period of [Term length], unless it is finished first as provided in this article. Each party may suspend this Agreement effectively at the end of the initial period by written communication at least ninety (90) days before the end of the initial period. Unless termination by cause, any party is responsible for the other or any other person for any loss or damage caused by termination of this Agreement, as provided in this Agreement. 4.
